CECE LYLES was a police officer with the FORT PIERCE POLICE DEPARTMENT
at that time. [redacted] CECE LYLES left the
police department on December 11, 2001 and started her training with
UNITED AIRLINES as a stewardess. [redacted] went to work for the
[redacted] on January 8, 2001.

[redacted] explained that CECE LYLES had received "ready
reserved" flight assignments with UNITED AIRLINES. On Monday,
September 10, 2001, she left Fort Myers and flew to Chicago via UNITED
AIRLINES, Flight 1699. In Chicago, she had a five hour delay until she
was able to obtain a flight from Chicago to Newark. She arrived in
Newark at 11:00 PM and called [redacted] via her cell phone and spoke with
him at that time. She told him she was taking a taxi to the location
that she rents with other stewardesses in Newark. He noted there was
nothing out of the ordinary about her conversation.

[redacted] explained that he works the 9PM-7AM shift. CECE LYLES
called him on the morning of September 11, 2001 at approximately 5:00
AM. She informed him that she was getting ready to go to work. She
asked him how his shift was going. She continued talking to him on her
way to the airport and while she was walking through the airport.
[redacted] commented that there was nothing unusual noted in the
conversation. At approximately 7:00 AM, she disconnected when she went
into her morning briefing with UNITED AIRLINES. At 7:20 AM, she re-
contacted [redacted] via her cell phone. She talked with [redacted] while she

was walking toward the plane and disconnected the phone once she got to the security gate. She re-connected while walking to the plane. CECE LYLES told [redacted] that she was going to have an easy day due to the flight load. She said that there was twenty-four passengers scheduled for coach class and eleven first class passengers. There were also five flight attendants aboard the flight. She was working in coach class that day. When she got to the gate to get onto the airplane, she told [redacted] she had to disconnect because a supervisor was at the gate. [redacted] commented that usually there is not a supervisor at the gate and she usually continues talking until she gets onto the airplane. [redacted] instructed her to call him when she got to San Francisco.

[redacted] advised that he went home and took his six year old son to school. After dropping his son off at school, he came home, watched ESPN Sports Center, ate breakfast and then went to sleep.

At 9:58 AM, [redacted] received a call at home from her cellular telephone. LYLES was in a deep sleep at the time and he awoke. [redacted] commented that CECE LYLES' telephone number [redacted] was the number on the caller ID. [redacted] subscribes to the SPRINT cellular telephone network.

The following was a discourse of the conversation:

LL: Hey baby. How you doing?
CCL: Babe, my plane is being hijacked, my plane is being hijacked.
CCL: Babe, they are forcing their way into the cockpit.
CCL: They forced their way into the cockpit.

[redacted] commented that she spoke in past tense, indicating that the hijackers had made their way into the cockpit. [redacted] recalled the following series of statements:

CCL: Babe, I called to tell you I love you, tell the kids that I love them.
CCL: Oh Lord, it feels like the plane is going down.

Thereafter, [redacted] heard screaming in the background and the phone went dead. [redacted] did not hear anyone giving commands.

LISA JEFFERSON, GTE Airphone Customer Service Representative, 2809 Butterfield Road, Oak Brook, Illinois, work phone number [REDACTED] was interviewed telephonically [REDACTED] at her residence, [REDACTED], Illinois, 60429. After being advised of the agent's identity and the nature of the interview, JEFFERSON provided the following information:

JEFFERSON received a phone call at approximately 8:45 a.m. Central time, September 11, 2001 from an individual aboard a commercial airliner. The caller identified himself as TODD BEAMER of Cranberry, New Jersey, a passenger aboard United Airlines (UAL) Flight 93 to San Francisco, departing at 8:00 a.m. Eastern time and landing 11:14 a.m. Pacific time. BEAMER called to state that the airplane was about to be highjacked. He stated that three individuals, two wielding knives, the third with a bomb strapped to his waist with a red belt, were preparing to take control of the flight.

JEFFERSON estimated that she spoke to BEAMER for seven minutes before the two highjackers armed with knives entered the cockpit, securing the door behind them. The third highjacker with the bomb remained in the main cabin with the passengers after closing the privacy curtain between First Class and Economy Class. BEAMER stated that after a short period, the aircraft maneuvered erratically and continued to do so. He stated that the aircraft was turning around. JEFFERSON noted that the call had an unusually low amount of background noise.

JEFFERSON continued her conversation with BEAMER for another eight minutes. During this time she could hear screams, prayers, exclamations, and talk of subduing the highjackers. At no time did she hear any discernable language other than English. At approximately 9:00 a.m. Central time, BEAMER said that the passengers were about to attack the highjackers.

Her last exchange with BEAMER, in which he asked JEFFERSON to call his pregnant wife, Lisa, [REDACTED] to tell them that he loved them, occurred at 9:00 a.m. Central time. Next, JEFFERSON heard another passenger give the go-ahead to make their move. After that point, she heard nothing. She kept the connection open for another twenty minutes without hearing anything, at which time she disconnected the call. During the call, tracking equipment indicated that the call was being serviced by a Pittsburgh transceiver, indicating that the aircraft was in that service area.

Approximately five minutes later, JEFFERSON received a call from [REDACTED] of Verizon Quality Control for residential service. [REDACTED] indicated that a passenger, JEREMY LNU, aboard UAL 93 was currently phoning his in-laws via an airphone. The in-laws contacted Verizon while remaining in contact with JEREMY. For some reason, Verizon contacted GTE Airphone during this call with JEREMY's in-laws. JEFFERSON could not hear JEREMY via this chain of calls. JEFFERSON received information second hand about the conversation between JEREMY and his in-laws via the Verizon employee. JEFFERSON estimates that this call came at 9:30 a.m. Central time. Conversation with Verizon continued until approximately 9:43 a.m. at which time the connection with the airphone ended.

Subsequent investigation determined that both Al-Hazmi and Al-Midhar resided in San Diego in 1999 and 2000.

[redacted] admitted that he was associated with telephone number [redacted] advised that he was enrolled at Grossmont College. A subsequent search of the computer by the San Diego Regional Computer Forensics Laboratory (RCFL) revealed several occurrences of email addresses, [redacted] and [redacted] It also revealed email messages from [redacted] The computer search also revealed an email address [redacted] to email account, ss3000@hotmail.com, On 10/30/2000 with the subject stating: "I'm very very sorry." The FBI has determined that Al-Hazmi utilized the ss3000@hotmail.com account in late 2000 through early March 2001.

On 01/10/2002 and 01/11/2002, SA [redacted] and Air Force Office of Special Investigations Special Agent [redacted] assigned to the Los Angeles Task Force on Terrorism, conducted a canvass of various hotels located on Sepulveda Blvd. in Culver City, California. The purpose of the this canvass was to determine if any of the individuals associated with the attacks of September 11, 2001 had stayed at these hotels.

Los Angeles had obtained information from FBI San Diego and FBI New York that Mr. AL MOHDAR MOHAMED ABDULLAH AL MOHDAR, a resident of San Diego who was interviewed as part of a proffer agreement at the Southern District of New York, had been introduced to NAWAF AL HAZMI and KHALID AL MIHDHAR, two of the hijackers on American Airlines Flight 77, by Mr. OMAR BAYOUMI, the spiritual leader of a Kurdish mosque in Magnolia, California. MOHDAR had further stated that in late Spring/early summer 2000, he and AL HAZMI and AL MIDHAR had taken a trip from San Diego to Los Angeles in order to drop off AL MIDHAR at the Los Angeles International Airport for a Lufthansa Airlines flight to Saudi Arabia. While in Los Angeles, the three stopped off at the King Fahad mosque in Culver City, California before continuing to an unnamed motel where they spent the night prior to going to the hotel. MOHDAR had further added that he did not know the name of the hotel, but advised that the hotel was the "middle one" of three in a row. MOHDAR recalled that AL HAZMI signed the register and paid for the room in cash, although MOHDAR did not recall whose identification AL HAZMI used to rent the room.
